You must provide proof of general liability coverage in the amount of \$1 million and name the market, the City of Syracuse and Westcott Community Center as an additional insured. A certificate must remain on file with the market.

Provide copies of all licenses and/or permits necessary to the types of products you are planning to sell; ie Board of Health permits, nursery license, etc.

I, the undersigned, do agree to abide by all of the rules and regulations. I understand that failure to comply with the rules and regulations could result in dismissal from the market.
